

To whom it may concern,

Parking management in the district of Wedding will be further expanded (see map overview). The following start date is planned:

- **1 December 2022, Parking Zone 81 (Koloniestraße/Wollankstraße)**

A number of residents have approached the Mitte district office in the past with demands for parking management to be introduced in this area. Due to the further compaction and increase in traffic, increased parking pressure has also been noticed in the district of Wedding. An independent expert investigation has confirmed this development, which is why the introduction of parking management seems necessary and appropriate to protect residents by driving back long-stay parkers from outside the area.

The following effects are achieved with the help of parking management:

- Residents, local businesses, customers and visitors find parking spaces more easily and quickly;
- Delivery vehicles find a parking space at the roadside more often;
- People are less likely to double-park and park illegally;
- Less traffic searching for parking spaces, achieving a general improvement of the traffic situation in the neighbourhood and more traffic safety;
- Noise and pollution are reduced

The following specific commitments were made:

- A new parking zone will be designated. The boundaries of the zone are shown on the map overview. is **EUR 1 per hour.**
- The management hours in Zone 81 are:  
**Monday to Friday: 9:00 am to 8:00 pm**
- As a general rule, the parking zone is identified using zone signs - signs are only displayed when entering or leaving the parking zone. There is normally no further indication of the parking fee/vignette obligation as the road continues.

Park management expansion in the Wedding district as of **1 December 2022**

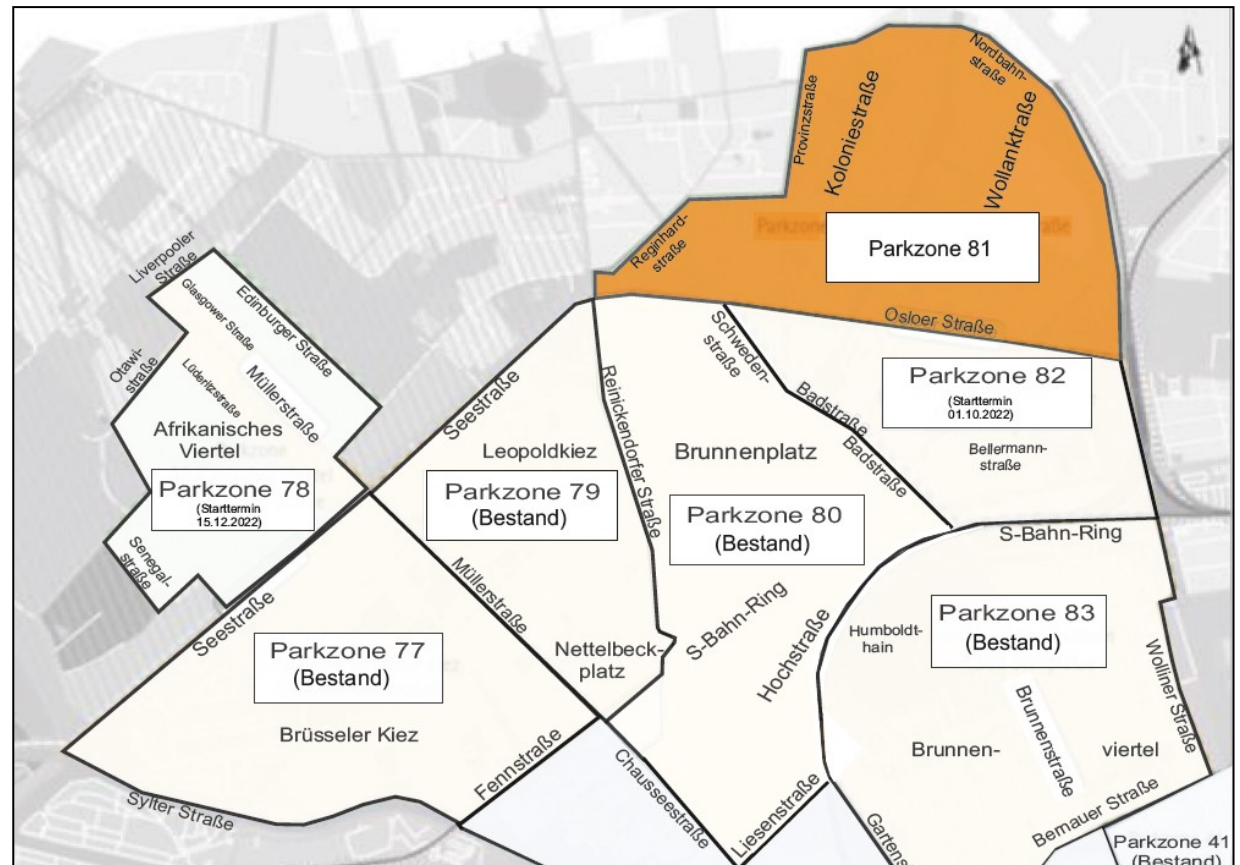

## Residents' parking permits/vignettes

Upon application, residents with an officially registered and actual place of residence within the zone will receive a resident's parking permit for one vehicle registered to them. This also applies to residents who provide proof that they have been given a vehicle for permanent use.

**The application for a residents' parking permit must be submitted online at <https://bit.ly/2XRK1f8>.**

The residents' parking permit can be issued for a period of up to two years.

The application must include:

- A scanned copy of the identity card or passport
- A scanned copy of the completely unfolded front of the registration certificate part I/motor vehicle registration certificate
- If applicable, transfer of use (informal attestation from the owner), if the applicant is not the owner of the vehicle
- The processing fees are currently € 20.40 for residents' parking permits (valid for 2 years).

**Please note: We ask that you apply for residents' parking permits in good time since parking violations can be prosecuted immediately after the introduction of parking management and applications must be processed in the order in which they are received!**

The application may also be submitted by post (Bezirksamt Mitte Berlin, Bürgeramt/BackOffice, 13341 Berlin) or email ([buergeramt@bamitte.berlin.de](mailto:buergeramt@bamitte.berlin.de)) only in exceptional cases. A personal application at the citizens' office is only possible in particularly urgent cases.

Residents' parking permits can only be applied for at the following citizens' offices (Bürgeramt):

If you are unable to submit your application online and have to submit your application in person, you will need an appointment to process your request, which you can book using the Berlin-wide appointment service.

## Company vignettes

Every business and comparable institution located within the new zone can generally apply to obtain a special permit for a company vignette for parking a company vehicle registered to the manager or the business, without having to provide proof of urgency. This does not apply to workers or employees.

The following are required for this:

- A written, informal application
- A copy of the business registration or proof of freelance work (e.g. letter from the tax office)
- A copy of the current lease
- A copy of the driving licence/registration certificate part I

The processing fees per vehicle are currently:

- 1 year € 90.00
- 2 years € 130.00
- 3 years € 160.00

Special permits for company vignettes for additional vehicles can be issued if applicants can prove that there is an irrefutable need due to the company's operations that goes beyond getting in and out of the vehicle and loading and unloading vehicles in the company's surrounding area.

Parking permits for tradesmen, special permits and company vignettes must be applied for exclusively at the Public Order Office. Please submit the corresponding application by email ([betriebsvignetten@ba-mitte.berlin.de](mailto:betriebsvignetten@ba-mitte.berlin.de)) or post:
