Information for (expectant) parents in Marzahn-Hellersdorf

Are you about to become a mother or father or do you have a newborn baby?

In that case, you will have lots to do: choose a midwife, get all the doctor's examinations done, take prenatal classes, register the acknowledgement of paternity, go to the registration office, inform the health insurance company, ask for parental leave, apply for child benefits and parental allowance, find a daycare and much more besides. The paperwork and dealing with German bureaucracy are quite time-consuming.

This guide **“What is important before and after giving birth”** contains all the information about what to do during your pregnancy and after giving birth. You will also learn about the financial and material benefits and when and where to apply for them and what documents you will need to do so.

The employer pays the net wage minus 13 euros for each working day covered by the health insurance company. If you receive ALG I unemployment benefits, the health insurance company pays. Apply for advance payments of child maintenance	A child has claim to an advance on maintenance payments until the end of its eighteenth year of life, when it lives with one of its parents. The respective parent must be single, widowed or divorced or live separately from their spouse and not receive regular child support from the other parent. This also applies to cases when the question of paternity is unresolved. Apply for domestic help	It is possible to apply for domestic help from your health insurance company if you cannot manage the household by yourself (due to health problems) and if there is no other person living in the household able to do so. You have to apply for it in person and it cannot be done by your doctor or midwife. Both can only attest to the necessity of domestic help or support the application. Either you or your health insurance company have to find someone for this job. In special emergency situations you can apply at the youth welfare office (Jugendamt), at your regional social services (Sozialpädagogischer Dienst).
